Role Overview:

The Multicultural Youth Case Manager is part of the organisations Client Services and Program Division. This role will deliver intensive case management support to CALD youth aged 12-24 and their families. The purpose of this support is to help high-risk CALD youth reduce their criminogenic risks and develop life skills. This position will also coordinate and provide a range of evidence-based and family support interventions relying on strong linkages between at-risk youth; local cultural, religious and community organisations.

This position will be on a fixed-term full-time basis (35 hours a week) and will end on 28/06/2024.

Key Accountabilities:

- Provide intensive case management services to the target CALD youth and their families and assist them based on their identified criminogenic needs.
- Develop comprehensive individual case plans, information and referral, and advocacy.
- Regularly review individualised case plans for each client working towards their goals.
- Deliver a range of evidence-based interventions to young people and their families to address risk factors.
- Facilitate the provision of interventional programs on relevant topics and services as identified to the target communities.
- Resource, support, and facilitate the establishment of support groups for the target CALD youth & their families.
- Ensure reporting internally and externally is accurate and submitted on time.
- Support and assist SydWest MS students and volunteers if required.
- Develop effective working relationships with local community groups and government and non-government agencies to meet the needs of target groups and projects in coordination with the Community Engagement and Disability Service Manager CEDSM.
- Participate in community consultation with the CE Team Leader: Youth and Capacity.
- Assist in organising events at organisational and project levels.

- A sound understanding of applying evidence-based interventions to address risk factors such as drug and alcohol, family functioning, education, housing supports and offence focused programs.
- Experience with and/or understanding the principles of 'strength-based' and 'person-centred' service planning and delivery.
- Demonstrated knowledge of Child Protection issues.
- High level interpersonal and communication skills and report writing.
- Effective interpersonal and cross-cultural communication and client advocacy skills to liaise effectively with all key stakeholders, including clients and their families, service providers, and communities.

- Demonstrated values of integrity, professionalism, and a commitment to quality and continuous improvement.
- Demonstrate understanding of individualisation of service and case planning based on static and dynamic risk levels, factors, and strengths.
- Demonstrated experience in planning, delivering and evaluating group activities and support groups.
- Demonstrate experience in using Risk/Needs Assessment tools to facilitate intervention planning.
